Whereas, the normal requirements of the law regarding 48 hours notice have not been met due to the inability to meet this time requirement, and


Whereas, notices of this Emergency Meeting were faxed to The Record and the Ridgewood News on Tuesday, April 3, 2012 at 3:30 p.m.

Approval of Memorandum of Understanding Between
Borough of Allendale and PBA Local No. 217

WHEREAS, the Collective Bargaining Agreement (“CBA”) between the Borough of Allendale (“Allendale”) and the Policemen’s Benevolent Association Local No. 217 (“PBA”) expired on December 31, 2011; and

WHEREAS, Allendale and the PBA have engaged in ongoing negotiations to discuss and agree upon the terms and conditions of a successor CBA; and

WHEREAS, as part of the negotiations for a successor CBA, a Memorandum of Understanding (“MOU”) between Allendale and the PBA has been agreed to between the parties; and

WHEREAS, Allendale wishes to memorialize its approval of the terms and conditions of the MOU.


