Approval of 5K Memorial Walk




Be It Further Resolved that the Woman's Club will secure appropriate liability insurance and sign a hold harmless agreement with the municipality.







Ordinance 13-13
SALARY ORDINANCE – 2013

AN ORDINANCE TO AMEND CHAPTER 67 OF THE CODE OF THE BOROUGH OF ALLENDALE TO FIX THE SALARIES, WAGES AND COMPENSATION OF THE OFFICERS AND EMPLOYEES OF THE BOROUGH OF ALLENDALE FOR THE YEAR 2013.

BE IT ORDAINED, by the Governing Body of the Borough of Allendale that the salaries of the following officers and employees of the Borough of Allendale shall be paid bi-weekly and fixed in the amounts as set forth below:
