A Regular Session Meeting of the Mayor and Council of the Borough of Allendale was held in the Municipal Building at 500 West Crescent Avenue, Allendale, NJ on May 28, 2020. However, due to the COVID-19 pandemic, access to the public was provided via GoToMeeting video and teleconferencing only, with adequate notice of same posted for public viewing. The meeting was called to order at 8:01p.m. by Mayor Bernstein who reminded the public to mute their phones so as not to distract from the business of the meeting. Mayor Bernstein advised the public that they would have several opportunities at appropriate times throughout this meeting to be heard.

Mayor Bernstein asked that the Acting Municipal Clerk read the open public meetings statement: “In compliance with the Open Public Meetings Act, the notice requirements have been satisfied. The meeting dates for the year are confirmed at the Annual Meeting, are posted on the public bulletin board in the Municipal Building, published in The Record within the first 10 days of the New Year, and copies are sent to The Ridgewood News and Star Ledger.”

The Mayor led those present in a salute to the flag.

Mayor Bernstein requested a moment of silence in memory of Richard “Dick” Van Houten who recently passed away. Mayor Bernstein mentioned how Dick was a distinguished member of the Allendale community and will be missed by all. Mayor Bernstein read from Dick’s obituary and noted that in September 2016 the Red Barn was dedicated to the Van Houten family, and in particular Dick, for their many contributions to the community, including at Crestwood Lake. Councilwoman Wilczynski shared fond memories of Dick and said that the Crestwood swing set, which Dick put in, is still in great shape and would remain in the park to be a legacy for Allendale to enjoy.

The May 14, 2020 Work and Regular Session Minutes were pulled and will be ready for approval at the June 11, 2020 meeting.

Committee Reports and Comments

Councilman O'Connell – Public Safety Committee

Councilman O'Connell shared an update on police (6,555), 911(595), fire department (47), and AVAC (151) calls (number) in Allendale. He shared that police department training is still cancelled until further notice. He advised that Councilwoman Wilczynski and Lake Manager Tom Viscardi met with OEM to discuss social distancing practices for the upcoming Crestwood season. Additionally, he noted that on June 2nd a public safety meeting will be held.

Councilman Sasso – Land Use and Construction Code

In addition to the introduction of Ordinance 20-10 Short Term Rentals, Councilman Sasso shared that he is working on updates to elements of the noise ordinance.

Councilwoman Homan – Water, Sewer, and Public Utilities

Councilwoman Homan announced that the Water Committee had a meeting earlier in the day with Mott MacDonald to review the preliminary report for the PFAS Feasibility study. She shared that she believes the report will be valuable for understanding future options. The Borough of Allendale has provided quality water to the residents via our own wells and bulk water purchases from Suez. She shared her appreciation for Jeff Picinich of Suez Water, Layne Simon and Ron Kistner for their efforts. She alerted the public about a mental health program on USRA Coalition's website through June 30th. Councilwoman Homan disclosed that her daughter has accepted an internship at Van Cleef Engineering, currently Allendale's engineer, and although

there is no legal conflict, she felt disclosure was important. Lastly, she expressed her gratitude for all those who worked on the Memorial Day video and to Joanne Hart who put together wonderful photos for the Allendale Historical Society.

Councilwoman Wilczynski – Facilities, Parks and Recreation

Councilwoman Wilczynski explained the committee's decision process to open Crestwood Lake on June 20th. She applauded Tom Viscardi for his efforts. They attended a virtual OEM meeting to discuss safety at the lake. Regarding 220/230, there was a very productive meeting with the chairman of the redevelopment firm and progress is being made. She expressed deep appreciation for the team's efforts. Councilwoman Wilczynski shared that there is a new Assembly bill circulating that introduces a street fair model for reopening businesses, allowing for the sale of merchandise outside. The bill also considers relaxing the blue laws during this COVID-19 time. She continued by stating there is a Bergen County Open Space grant for trails that will have a public hearing at the council meeting on June 11th and the streetscape project bids will open on June 5th.

Councilman O'Toole – Administration, Finance and Human Resources

Councilman O'Toole shared that following the adoption of the budget, the finance team is keeping an eye on spending. The next committee meeting is scheduled for June 4th.

Councilman Strauch

Councilman Strauch thanked everyone involved in the Memorial Day virtual ceremony. He applauded every member of the DPW for their commitment to making Allendale a model community and handling the challenges brought about by COVID-19 in stride. He further expressed gratitude for the Garden Club and all other volunteers who make Allendale a beautiful town. Mark Savastano will be giving an update during public comments on the recycling advisory committee's efforts.

Mayor's Report

Mayor Bernstein gave the following address to the public:

On Monday we celebrated Memorial Day and honored all the fallen heroes through a virtual remembrance service. I was honored to work with and give a heartfelt thanks to the VFW and Commander Joseph Chinnici as well as Collette Mather and students from the Brookside School, our Councilmembers and First Responders for helping to recognize this special day. Thank you to Joe Hart for his emotional rendition of taps, Tyler Yaccarino and John Gil for creating the video and Ron Kistner for working behind the scenes to get it all done. While the traditions that we are used to were not able to happen we were able to share the meaning of this holiday with residents who watched along at home. I want to thank everyone who had a part in making it a memorable event and if you haven't seen it, I invite you to go onto our website – allendalenj.gov – to watch it. As we begin the summer, I remain hopeful that our routines will begin to be a little normal as the trends we are seeing around our area continue to look more positive.

To date there are 68 positive COVID-19 cases. As I've been reporting every week, Allendale's number remains one of the lowest in Bergen County. These numbers are

largely because we are doing our part. The following testing centers are open - Bergen Community College, Bergen New Bridge Medical Center, and Rite Aid in Waldwick.

This pandemic has been a stressful time and has affected many people in different ways. If you or someone you know may be struggling with heightened mental health issues during this time or if you, a neighbor or someone in your family is feeling isolated or anxious please know that resources are available. The CBH Care Wellness and Support Center located in Hackensack is Bergen County's urgent care center for mental health services. Please call 201-957-1800 to access services.

While restrictions on social distancing remain in place as outlined in his Executive Order, Governor Murphy has outlined "The Road Back". We are in Stage 1 currently and some restrictions on low-risk activities – such as enjoying parks and beaches - have been relaxed. Non-essential construction, curbside retail, elective surgeries have resumed with appropriate safeguards. We are anxiously awaiting State 2. I encourage everyone to continue to be mindful and to stay safe using social distancing guidelines. Any concerns related to large group gatherings or violations of the executive order should be directed to the Allendale PD. I want to thank Chief Scherb and the entire Police Department for all of their continued efforts during this trying time.

Please note that the primary election has been moved to July 7th. Tuesday, June 16, 2020 is the deadline for all new voter registrations for the Primary Election. The Clerk's Office will be open for registration until 9:00PM that night. As more information is received from the State and the County, we will post it on our website.

The Celery Farm remains closed as social distancing on the trails' narrow passageways is not practical. As soon as it makes sense, we will open. Crestwood Park is open for passive recreation only. The playground, tennis courts and fields are closed. Do not swim in the lake yet! I cannot stress enough that the lake is not treated yet, no lifeguards are on duty and Allendale Police are patrolling. As mentioned earlier, Crestwood Lake will be opening on June 20th. Thank you to Councilwoman Wilczynski and Lake Director Tom Viscardi for their tireless efforts to open this season. Registration is open on our website.

While remote learning remains in place through the end of the school year, Governor Murphy announced this week that in-person graduation ceremonies will be able to take place beginning on July 6th. We await the decisions of the Allendale and Northern Highlands schools, but with the proper precautions in place and compliance with social distancing guidelines, it could be a special opportunity for all 2020 graduates to receive the recognition they have worked so hard for and deserve. I want to personally congratulate everyone who is graduating this year – I wish you much continued success in the future! I hope to attend any ceremonies in your honor.

As I had mentioned at the last meeting the Holiday Observers have postponed their 4th of July celebration until September 12th. Information regarding all of their events can be found on their website www.holidayobservers.org.

The Compost Center on West Crescent Ave is open to current 2020 permit holders. We encourage all residents to use their best judgement when coming in to the compost center and please remember that no borough employees will be available to assist with unloading of materials. A permit can be applied for by going to the website, www.allendalenj.gov, and payment can be dropped off at Borough Hall in the mail slot at the back entrance or postal mailed. The compost facility is open Thursdays and Fridays from 9am to 2:30pm and Saturdays 9am to 3pm at this time.

I am happy to announce that Suburban Disposal has notified us that town-wide metal pick-up has resumed. They were in town yesterday and today. If you missed the chance to put out your metal they will be back again on Wednesday, June 24th. All metal items should be left at the curb and should be clearly visible. We recommended items be out after 6:00pm the night before. We have also transitioned into twice a week garbage pickup. The full schedule of pickup dates is listed on our website.

And finally, Allendale's Census response rate is now at 75.6%! Let's keep those responses coming so we are fully counted and represented!

Staff Report:

Mr. Wiss, Borough Attorney reported that, in addition to working with Mr. Kistner on personnel reports and negotiation matters, all his work is reflected on the agenda.

Ms. Ryan and Mr. Kistner did not have anything to report.

Public Comment on any issue:

Mr. Savastano, 22 Vreeland Place, advised of his conversation with Councilmen Strauch and O'Connell regarding Styrofoam recycling and its importance and environmental benefits. He thanked his neighbor, Frank Paparozzi, for his conscious effort to recycle materials during his construction project. Mayor Bernstein applauded everyone for their efforts.

Frank Paparozzi, 25 Vreeland Place, commended the governing body on their actions to open Crestwood Lake and also to introduce Ordinance 20-10. Mr. Paparozzi expressed his appreciation for their efforts to make the community less transient and a safe place to live.

No other public came forward to comment.

Adjournment

There being no further business to come before the Mayor and Council, on a motion by Councilman Strauch, with second by Councilwoman Wilczynski, and unanimously carried, the meeting was adjourned at 8:57p.m.

ORDINANCE NO. 20-10

**AN ORDINANCE ESTABLISHING
CHAPTER 181 OF THE CODE OF
THE BOROUGH OF ALLENDALE**

BE IT ORDAINED by the Mayor and Council of the Borough of Allendale that Chapter 181 of the Code of the Borough of Allendale is hereby created and enacted as follows:

Chapter 181. Short Term Rentals

§ 181-1. Short-term rental property.

Notwithstanding anything to the contrary in the Borough Code, it shall be unlawful for any person, including, but not limited to, an owner, lessor, or sublessor with any possessory interest in any dwelling, to receive compensation of any kind for the use, occupancy, or rental of any dwelling for a period of 30 days or less.

§ 181-2. Enforcement.


The provisions of this chapter shall be enforced by the Borough Zoning Officer, Fire Department, Police Department and any other Borough official or employee so designated by the Mayor who all shall be authorized to issue summons or other appropriate civil violations or complaints for any violations of the terms and provisions of this chapter.

§ 181-3 Fines; violations and penalties.

Any person who is found or adjudicated to have violated any provisions of this chapter shall be liable for a fine not to exceed \$1,000. Each day of any such violation after receiving written notice of same shall be a new and separate violation.

WHEREAS, the Facilities, Parks and Recreation Committee reviews said rules and regulations periodically and makes recommendations for updates and changes; and






